VACATION APPLICATION PERIOD IS STILL OPEN SO PLEASE APPLY

The Vacation Application period is open from **February 1, 2022** thru **February 28, 2022** for all Seniority Members to make a vacation selection from April 1, 2022 thru March 31. 2023. After this signup period, vacation will be handled on a first come first serve basis. (*NO SHUTDOWN WEEKS HAVE BEEN IDENTIFIED BY THE CORPORATION*)

(202c) Management at each plant will establish a procedure whereby employees, during February, may make application in writing for vacation time off, indicating first, second and third choices. If Plant Vacation Shutdown Weeks are scheduled, the dates of such shutdown weeks are to be included in the employee's vacation schedule.

Pursuant to the terms of the UAW-GM National Agreement (202a), <u>Plants that have an identified launch may schedule</u> <u>up to (2) two Plant Vacation Shutdown Week(s)</u>. <u>Management</u> will identify the specific week(<u>s</u>) such shutdown(<u>s</u>) will occur. <u>For locations in launch</u>, Plant Management may schedule the Plant Vacation Shutdown Week(<u>s</u>) to take place <u>anytime during April through November</u>, or, with the local union's agreement, during other week(<u>s</u>) more advantageous to plant operations.

RE: GM Profits/Profit Sharing – 2021 North America – Earnings Before Income Tax (EBIT)

Dear Union Brothers and Sisters:

Today, General Motors announced North America Earnings Before Income Tax (EBIT) for 2021 to be \$10.3 billion.

In accordance with the terms of the 2019 UAW-GM National Agreement, each eligible member will receive up to a **\$10,250** payout for 2021 Profit Sharing. These contractual payments will be made on Friday, **February 25, 2022**.
