Bylaws Article 13, Section 8: "At a...Membership Meeting duly designated for the purpose of nominating candidates for office, a member of Local 276, UAW, in good standing, may nominate another member of Local 276, UAW, in good standing, as a candidate. Potential Candidates who have been laid-off or discharged, to be deemed as being in continuous good standing between April 16, 2022, and April 15, 2023, must have been covered by "out-of-work credits" according to International UAW Constitution, Article 16, Section 26: "A member who has been laid off...or is discharged from regular employment...shall automatically be considered as entitled to 'out-of -work' credits, unless s/he has received benefits in lieu of work equivalent to forty (40) hours' pay...Any member in order to be entitled to 'outoff-work' credits shall report her/his layoff...or discharge, in person or otherwise, to the Financial Secretary of her/his Local within one month of the date such action became effective..."

- I. Candidates desiring to have a Challenger(s) for any of the elections, run-offs, or counting of the ballots must complete a "Challenger Request Form" at the UAW Local 276 Union Hall the deadline to submit the request for a Challenger(s) is 5:00 PM on the immediate Thursday before the Election or Run-Off Election. [Example: The election will be on Tuesday, May 2, 2023. The "Challenger Request Form" must be submitted before 5:00 PM on Thursday, April 27, 2023.] Challenger(s) Request Forms submitted after the deadline will not be accepted and the Challenger will not be allowed in the voting area.
- II. Per UAW Local 276 Bylaws Article 13, Section 19. A. (1): "An eligible member who will be away from UAW Local 276 during the entire period of an election of Executive Officers or Convention Delegates on a work assignment from the member's employer or on UAW Local 276 business may apply in person for an absentee ballot by completing a signed statement that s/he will be away from UAW Local 276 for the entire period of the election on a work assignment from the member's employer or on UAW Local 276 business." [No other absences will apply.]
- III. Absentee voting is ONLY allowed for Executive Board positions and Constitution Convention Delegates. [International Union, UAW, Constitution, Article 38, Section 10(b)(1)1].

- IV. The following is prohibited within a 100-foot radius of the voting area(s). Anyone violating these regulations will be removed from the voting area:

 - C. Cannot contact anyone by any means to report on how the voting is going by any type of communication in person, phone, text, social media, etc.
 - D. Cannot use cell phones
 - E. Cannot use laptops
 - F. Cannot use tablets
 - G. Cannot use E-Readers
 - H. Cannot use iPods
 - I. Cannot use Smart Watches
 - J. Cannot use TVs
 - K. Cannot use any other type of electronic device not listed above.
- V. When coming to vote, you must:
 - A. Check the GM District, Caravan Shift, or HydroChem Shift you vote in **BEFORE** entering the voting area.
 - B. When entering the voting area, look for the sign with your GM District, Caravan Shift, or HydroChem Shift.
 - C. Approach the voting table to get your ballot (have your Badge or Driver License ready.)
 - D. Go to the voting booth to mark your ballot.
 - E. After your ballot is marked, place it in the ballot box.
